I. Fostering Bilateral Trade

OUTBOUND TRADE MISSIONS



AmCham and Delta Air Lines visited Atlanta to plan the upcoming Atlanta Trade Mission. A delegation from AmCham traveled to Atlanta for 3 days accompanied by Jeannette Diaz Granados, Sales Manager for Delta Air lines to meet with several organizations in preparation for the upcoming Atlanta Trade Mission in August 26-29. During this brief trip, the AmCham Delegation met with Bettina Gardner, from the Office of the Mayor; Ricardo Hubler of the Metro Atlanta Chamber of Commerce; Santiago Marquez of the Georgia Hispanic Chamber of Commerce; Sonia Tucker, Chief of Protocol Affairs of CNN.

AmCham 1st outbound trade mission to Tampa Bay, Florida. The purpose of this Trade Mission was to present business opportunities between Tampa Bay, whose port is the largest of Florida and the Panamanian business sector. The mission took place from May 6 to 9 this year.



On this occasion, AMCHAM joined key government representatives such as Panama's Minister of Tourism, the Director of Investment Promotion of the Ministry of Commerce & Industry, the Administrator of the Panama Pacific Agency, and about 30 Panamanian businessmen in logistics industries, tourism and Research and Development (R&D).
